

Privacy Notice

Keeping customer information secure is a top priority at Rance King Securities Corporation. The information is used to ensure accuracy in record keeping and to carry out requested transactions. We are sending you this notice to help you understand how we handle and protect personal information we receive about you.

We collect non-public information about you from the following sources:

- Information we receive from you on applications or other forms, such as your name, address, social security number, annual income and investment objectives;
- Information about your transactions with us or others; and
- Information we may receive from consumer reporting agencies.

Access to your personal and account information is restricted to those employees who need to know that information in order to provide products or services to you. We also maintain physical, electronic, and procedural safeguards to guard your nonpublic personal information.

We do not sell your nonpublic personal information to anyone nor do we disclose any such information about former or current clients to any third parties, except as required by law. If you decide to close your account(s) or become an inactive customer, we will adhere to the privacy policies and practices as described herein.

You are entitled to receive a copy of all of your personal data that we collect. Such a request may be made twice within a 12 month period.
